These enhancements also bring Band 14 spectrum to the area. Band 14 is nationwide, high-quality spectrum set aside by the government specifically for FirstNet. We look at Band 14 as public safety's VIP lane. In an emergency, this band – or lane – can be cleared and locked just for FirstNet subscribers. When not in use by FirstNet subscribers, AT&T customers can enjoy Band 14's added coverage and capacity.

[FirstNet](#) is built with AT&T in a public-private partnership with the First Responder Network Authority. It's designed to help first responders in Minnesota and across the country connect to the



critical information they need – when they need it – so they can keep themselves and the communities they serve safer.

### **We're committed to our networks in Minnesota**

At [AT&T](#), we've invested more than \$300 million in our Minnesota wireless network during 2017-2019. In 2020, we made almost 2,000 network enhancements across Minnesota, including new cell sites, additional network capacity, network upgrades and small cells. From 2010 to 2019, AT&T invested nearly \$1.2 billion in our Minnesota network.

We also launched AT&T 5G nationwide in 2020, including in communities across Minnesota such as Worthington, Rochester, Duluth, St. Cloud, Bemidji, Mankato, Brainerd and the Twin Cities, among others.
